A Nine STR Locus Match Between Two Apparently Unrelated Individuals Using $AmpF\ell STR^{\mathfrak{G}} \ Profiler \ Plus^{TM} \ and \ COfiler^{TM}$

The Arizona Department of Public Safety Crime Laboratory is reporting a nine STR locus match between two apparently unrelated individuals at vWA, D21S11, D5S818, D13S317, D7S820, D16S539, TH01, TPCX, and CSF1PO. The samples were analyzed by Myriad Genetic Laboratories, using Applied Biosystem's AmpFlSTR® Profiler PlusTM and COfilerTM kits. The nine STR locus match was discovered during a duplicate search by Myriad Genetic Laboratories. Further investigation by the Arizona Department of Public Safety revealed that one offender is Caucasian while the other offender is Black. In addition, it was noted that the two offenders share one aliele at three of the remaining four loci, D3S1358, D8S1179, and D18S51. The match was confirmed with Applied Biosystem's AmpFlSTR® IdentifilerTM kit.

METHOD

DNA was extracted from 3.0 μl of liquid blood with Chelex. The samples were amplified using a 9500 thermal cycler with the Applied Biosystem's AmpFlSTR[®] IdentifilerTM kit (25 μl reaction volume). The samples were analyzed on the ABI Prism 310 Genetic Analyzer.

RESULTS

The two convicted offender samples were found to match at nine loci. Using the FBI Popstats database, the frequency of this nine locus profile is as follows:

- 1 in 754,100,000 Caucasians
- 1 in 561,500,000 African Americans
- 1 ir. 2,376,000,000 Southeast Hispanics
- 1 in 113,500,000,000 Southwest Hispanics
